Immunization Records...It's the law

I am confident that most of our parents are aware that The School Immunization Law in Minnesota requires all parents of students enrolled in grades kindergarten through 12 to show they have received certain timely immunizations or have an

official exemption on file with their school, but we still have a high percentage of our families who are not in compliance with this requirement and we are obligated to get that corrected soon.

We have made several attempts to communicate with each of the families whose records need attention, but in some cases, we still haven't gotten a response. The school is required to report the immunization status of all of our children to the Minnesota Department of Health each year, and we hope to have the opportunity to demonstrate that our families are complying with this expectation. Be advised that school systems, in certain cases, will disallow students who are not in compliance with this legislation from attending school in person until the matter is resolved. So, I am writing in this month's letter as a final attempt to remind all parents that we need to work together to demonstrate that the school is in compliance with the education laws in state of Minnesota.

Here are the possibilities and options for all of our families:

- Your family is in compliance with immunization requirements and the school has a record of all of your enrolled children's immunizations to date.
- Your family is in compliance because you have completed, and had notarized, an objection to the immunizations and that document is on file with the school.
- You are unaware of what immunizations are required and need assistance in knowing what to do.
- You do not want your child(ren) to receive the immunizations, but you do not know how to file the official objection.

Attached, you will find a chart that illustrates, by age, exactly which immunizations a child is required to have if they are to be enrolled in a public school. Your family's primary physician or pediatrician

will also know exactly which immunizations are needed and will assist you. All you have to do is schedule an appointment to get this taken care of.

If you are not open to these immunizations, you will need to complete an objection form and have it notarized, then bring it to school after having it notarized and your family will be in compliance. Again, we at the school do not wish to disallow any child from attending school but, as a public school, we have rules to follow as well. It is critically important that our parents <u>read this</u> <u>information</u> and do your part to comply. If you still remain confused or uncertain about what to do, you are invited to call the school and we can guide you. Failure to act could result in students being disallowed from attending school until the matter is resolved.

Aside from this newsletter, the school will make one more attempt to contact each family who has one or more children who are not in compliance with this law. Our goal is to politely remind these families that we are obligated to comply with the law and we will make every effort to ensure that no child is disallowed from attending school due to a lack of compliance. If you are unsure about what this all means, please call the school at your first opportunity.

Winter Months

Be reminded that winter weather can cause the school to close for one or more days. That said, just because the snow falls does not mean we will cancel school. Living in the region makes us a bit crazy, but also makes us a bit hearty. So, when

driving becomes dangerous, or the temps reach dangerous lows, school could get canceled for the day.

When weather threatens, we will post the closure and notify families in the following ways:

- Post on local news channels 4, 5, 9, and 11
- Post to Facebook
- Post to the school's website on the main page
- Send out JMC messages via text and email

As you can see, we will offer various ways of notifying our families, but you will have to be watching one of these platforms or you will not know we are closing. If you as a parent feel the weather or driving conditions are not



safe to drive your kids, have them drive to school, or even to send them on the bus, you should keep them home and call the absence in and state the actual reason why you are keeping them home. We will understand. You may even do this because of a weather report, but that reason will likely be questioned. We have actually closed school due to a weather report that ended up not happening as forecasted...it never actually snowed. But, the worst that happens is that it would get recorded as an "unexcused" absence.

The point of this section is simply to remind you to be aware of the weather and make the best choice you can. Report the actual reason for the absences and the school will record it. Monitor the school's communication platforms when weather threatens.

Baby Counselor

Many of you have stopped by the school and recently had an encounter with Mrs. Massmann, our school counselor. You likely noticed she was getting closer to having a new baby. Well, that day has finally arrived. Mrs. Massmann is pleased to announce that she and her husband are the proud parents of their new baby boy Elliot, who arrived just after the Thanksgiving



holiday. Aside from celebrating his birth, we are notifying our families that Mrs. Massmann will obviously be taking some time off so we will not have her on campus for the next few months. We know that she provides a lot of services to our students, but those services will not be available in the same form until she returns. We will provide an update in the next newsletter regarding her anticipated return date.


End of Semester 1


Are Your Kids Ready?

What Minnesota's Immunization Law Requires

Immunization Requirements

Use this chart as a guide to determine which vaccines are required to enroll in child care, early childhood
programs, and school (online, home school, public, or private).

Find the child's age/grade level and look to see if your child had the number of shots shown by the checkmarks under each vaccine. The table on the back shows the ages when doses are due.



Immunizations recommended but not required:

COVID-19

For all children in an eligible age group

Influenza

Annually for all children age 6 months and older

Human papillomavirus At age 11-12 years

1 Not required after 24 months.

Rotavirus

For infants

If the child has already had chickenpox disease, varicella shots are not required. If the disease occurred after 2010, the child's doctor must sign a form confirming disease.

- (3) First graders who are 6 years old and younger must follow the polio and DTaP/DT schedules for kindergarten.
- 4 Fifth shot of DTaP not needed if fourth shot was after age 4. Final dose of DTaP on or after age 4.
- 5 Fourth shot of polio not needed if third shot was after age 4. Final dose of polio on or after age 4.

6 One dose must have been pertussis-containing (i.e., DTaP or Tdap) and one dose must have been given after the fourth

- birthday. If the first dose in the series was given before age 12 months, then four doses are needed.
- 7 An alternate two-shot schedule of hepatitis B may also be used for kids age 11 through 15 years.

8 At least one dose must have been given after the fourth birthday. If the third dose was given before the fourth birthday, a fourth dose is needed.

One dose of meningococcal ACWY is required beginning at 7th grade. The meningococcal ACWY booster dose is recommended at 16 years and required for 12th grade students.

Exemptions To enroll in child care, early childhood programs, and school in Minnesota, children must show they've had these immunizations or file a legal exemption.

Parents may file a medical exemption signed by a health care provider or a non-medical exemption signed by a parent/guardian and notarized.
