

Inclement Weather

Moving forward, the status of New Heights is going to remain as "open" until I make a formal announcement about a status change. If any of our families get a district notification about a change of district school status, that doesn't necessarily mean that the status of New Heights is going to change. Our families should remain patient and watch for an announcement in the following places—first, we will post our status change on the 4 local television networks Wcco 4; KSTP 5; Fox 9; KARE 11. Next, we will post the status change on the school's website, Facebook page, JMC, and we will send a text to

the parent who is listed as "Primary Parent" in our system. In the event that school may be "closed" for the day, it will likely do you no good to call the school to ask because there is a good chance that none of us will make the trip into school that

day due to the safety challenges the weather event is likely causing. So, once we are given the district's decision, we will follow suit by choosing the most appropriate option, if we have any, and we will notify our families within minutes of making the decision. You should only react to an official notice from New Heights School in order to minimize any confusion about the status change. Seeing or receiving a notification from Stillwater District can be used as a tool to predict that you will likely get notice from New Heights soon, but you should not automatically believe that the options available to New Heights are the exact same as those available to the district-they are not exactly the same.

Finally, you may be wondering what you should do as a parent if you have concerns about safety. New Heights has always maintained the position that parents should always make the decision that seems best or most appropriate for your family in weather-related situations. All families do not have the same distances to travel to and from school, have the same type of vehicles, have the same flexibility to miss work, or, there may be other things to consider when wondering whether or not to send your children to school. To put more clearly, if you are concerned about safety when it comes to sending your children to school, driving them to school, allowing them to walk to school, or allowing them to drive themselves to school, you should probably consider keeping them home. Students who stay home due to legitimate weather-related safety reasons are not given any attendancerelated consequences whatsoever. We will understand why you chose to keep your children home and we will not question it. Simply call the school and leave a message on the answering service if you are not able to speak with someone directly to let them know about your decision. In the end, we prefer for our students to be

safe. Missing a day of school in the name of safety makes the most sense of all of the other alternatives. Hopefully this section will be read by all of our parents and we further hope that you will find this information somewhat helpful.

Official School Hours

As a reminder, the official hours of operation for New Heights on school days are 8 am to 4 pm. We do not have a before school or after

school program or daycare, so we ask that students not arrive at school until 8:45, and in cases where parents pick their children up after school we ask that they are responsible to get them by 4pm. In the event that a parent runs into difficulty and



they know they are going to be late, kindly call the school and notify them that you will be late along with your ETA and we will ensure that your children will be able to wait in a safe and supervised area. With regard to early arrival in the mornings, staff generally report to school at 8am, but teachers have very little time to prepare for the upcoming day. The hour prior to school is reserved for teachers to prepare for the day and also for meeting with one another as a staff, which means the teachers are generally not available to supervise children until 8:45. Of course, in isolated circumstances, we will work with you and allow for an occasional early drop-off due to an unusual circumstance, but families should not routinely drop children off ahead of 8:45 unless special arrangements have been made.

Casual Early Release and Tardy to School

Parents are reminded that children are required by law to attend school until 18 years of age. One of the reasons the school calendar looks like it does is to ensure that schools offer the required number of hours that students are expected to be in school. When students aren't in school at the minimum prescribed rate, the government

expects school leaders to work with families to fix the issue or submit a truancy report and get the local county involved. So, school is not intended to be a casual experience. It is more accurate to consider the school experience as a responsibility or requirement. Therefore, I want to remind families that students enrolled at New Heights are expected to maintain a level of 90% or higher rate of attendance in all classes they are scheduled for. It is not a good practice to routinely drop off late of pick students up early unless there is an appointment, illness, important family matter, or other critical business to attend to. Late drop offs or early dismissal for convenience sake will not be considered as an excused absence and unexcused absences can have a negative impact on learning and grades. Please remember that school is the training center for the world of work and attendance is one of areas that employers deem as being high on the list of importance. Students are building important habits now and they will do better to think of school as important and necessary, and attending school day on time and staying at school for the entire scheduled day is among the core values in place at New Heights. End of Semester 1 and Quarter 2

The school year is divided into sections; 4 quarters and 2 semesters. Students in grades K-5 receive progress reports or report cards at the end of each quarter. Students in grades 6-12 will also receive quarterly reports, but the official grade is based on a semester or half a school year. Quarter and 1 and 2 combine into

one semester grade and for students in grades 9-12, they will receive semester credit needed to graduate from high school with a diploma. The end of quarter 2 and semester 1 will be January 27th.That is important to know because that means that students will have 3 weeks after winter break to make sure to complete enough work in each class in order to pass their classes in grades 6-12. Attendance at our fall conference day was low this year, so hopefully parents are checking the JMC Family Access portal to

monitor your child's grades and make the necessary arrangements in time to ensure that your child can and will pass his or her classes. You can also email individual teachers if you have questions.

1. What inspired you to become a teacher?

Ever since I was young, I loved reading and learning. I especially enjoyed learning all I could about history. As a student, I had many amazing social studies teachers, such as Mr. Tviet for 6th grade Minnesota history, who also taught my dad! These teachers made me want to help teach and inspire students just like they did.

2. What do you enjoy most about teaching?

I would say the two things I enjoy the most about teaching are building positive relationships and seeing students really engage with the content.

3. What is the most exciting thing you've ever done?

The most exciting thing I've done was traveling to Ireland, Wales, Britain, and France on a school trip the summer after I graduated high school in 2017. A few highlights of that trip were visiting the Sherlock Holmes Museum,

Shakespeare's birthplace, and staying in a supposedly haunted hotel room in Wales!

4. What is something people would be surprised to know about you?

I was hospitalized with a large blood clot in my left leg when I was only 21. This led to me discovering that I have a genetic blood clotting disorder called Factor V Leiden. It is a very common disorder, and many people can live their whole lives without it causing any issues, which is why they may not know they have it.

5. What do you enjoy doing in your free time?

When I have free time, I enjoy reading, listening to podcasts, singing, going on walks, spending time with family and friends, and hanging out at home with my husband and our two cats.
